- Application fees Rs. 200/- for applying candidate should submit **demand draft** in the name "**District Health & Family Welfare Society, Kaithal**" payable at Kaithal. This Fees is not refundable. No application will be entertain without proper fee. The demand draft issued between date of advertisement and closing date only will be accepted.
- **Please carefully read selection criteria before filing the application form.**
- Applications will be accepted in NHM office of Civil Surgeon, Kaithal on all the working days up to 28.09.2022 at 05:00 PM Sharp. The by hand application will be accepted only in working days and working hours of the office. That is 09:00 AM to 05:00 PM (On Saturday Sunday and Gazetted Holiday the office will remain closed).
- Unfilled and unsigned application forms will be considered as rejected.
- If a candidate has passed his/her Education from Private/Deem university then/he/she has to submit UGC approved certificate for university and Course for the period of concerned year of passing.
- Important Notice for all Candidates:- Any sort of canvassing or influencing the officers related to selection and recruitment process would result in immediate disqualification of the candidate.

- Original documents in support of academic qualifications and work experience shall be required to be produced at the time of document verification.
- Preference will be given to the candidate residing in local area and proof of residence will be required as per letter no. NHM/Admin/HRC-1/2021-22/7591-7620 dated 20.09.2021 for clamming local area residential weight age any three of the following documents must be submitted along with application from: (i) Passport (ii) Election Card ID Card (iii) Ration Card with Address (iv) Bank Passport/ Post Office Pass Book (v) Caste and Domicile Certificate with address and the photo issued by State Govt. (vi) Parivar Pechan Patra (vii) Electricity Bill (Not older than last three months).
- **No weightage will be given in absence of minimum three residential proofs (of the above mentioned seven documents).**
- Service bye laws of NHM 2018 will be applicable for all the posts.
- Number of Posts can be increased or decreased by the NHM. These posts may be discontinued at any time depending upon the work load, requirement or validity of the project.

- Post of reserve category will be filled up as per Haryana Government Policy.
- All the posts are non-transferrable and the selected candidate will remain posted at the place of appointment.
- Any additional work/placement under NHM can be assigned by appointing authority.
- It is mandatory for staff to maintain H.Q and reside at the place of posting.
- No separate call letter issue for the interview.
