- Number of Posts can be increased or decreased by the competent Authority.
- Post of reserve category will be filled up as per Haryana Government Policy. Candidates seeking selection under Ex- service man category will have to deposit eligibility certificate from respective Zila Sainak Board. To become eligible certificate must be issued/renewed before the date of this advertisement.
- All the posts are non-transferrable and the selected candidate will remain posted at the place of appointment.
- Any additional work/placement under ATF can be assigned by appointing authority.
- It is mandatory for staff to maintain H.Q and reside at the place of posting.
